Syed Ahmad Ullah Maizbhandari (1826-1906), a very renowned Islamic Jurist, Professor of Islamic Studies, and famous Sufi-Master, founded the Maizbhandari Tariqa in the late 19th century. The Maizbhandari Tariqa is the only Sufi order that is originated in Bengal. The tariqa emphasizes self-purification, tolerance, interfaith harmony, coexistence, and the importance of giving priority to the will of Allah by distinguishing the concepts of *Usul-e Sab'a*, *Wilayat-e- Mutlaga*, *Adal-e-Mutlag*, and Tawhid-e-Adyan. The tariqa draws its legacy mainly from the teachings of Shaykh Ibn Arabi (1165-1240) and Shaykh Abd al-Ghani Ibn Ismail al-Nabalusi (1641-1731). It has maintained a very significant influence and popularity throughout the 19th to the 21st centuries by drawing a huge number of adherents from the various social strata in South Asia and the South Asian Diasporas in various continents around the globe irrespective of race, religion, cast, and creed. Still, it is one of the fastest growing tarique with its huge number of devotees and adherents around the globe as a research report prepared by the Migration Review Tribunal (MRT) and Refugee Review Tribunal (RRT) of Australia reported that the order has over ten million followers. Without compromising its adherence to Islam, the tariqa relishes various features like liberality, inclusiveness, adaptive nature and cultural diversity. The tariqa acts as an influential and very effective shield to safeguard individuals, in their private and public sphere, from both religious conservatism and atheism with its values and practices.

The tariqa has a substantial body of written works, including hagiographies and theological treatises. It is also known for its unique genre of devotional songs that created a very significant 'Sufi-folk' genre named *Maizbhandari Gaan*. Besides *Wilayat-e-Mutalaqa* by Syed Delawor Hossain, the very basic book on the tariqa, there are a number of books, book chapters, newspaper and periodical articles, and peer reviewed academic journal articles on the tariqa. Among those Aminul Haq Farhadabadi's *Tuḥfat al-aḥyār fī daf' šarārat al-šarār* (1906), Abdul Ghani Kanchanpuri's Ā'īna-i Bārī (1913), Sarwar Alam's *Cultural Fusion of Sufi Islam: Alternative Paths to Mystical Faith*, Routledge Studies in Religion (2019), Amit Dey's The Image of the Prophet in Bengali Muslim Piety, 1850-1947 (2005), Hans Harder's *Sufism and Saint Veneration in Contemporary Bangladesh: The Maijbhandaris of Chittagong, Routledge* (2011), and Peter J. Bertocci's "A Sufi movement in Bangladesh: The Maijbhandari tariqa and its followers" are a few to mention.

Part of the celebration of the bicentennial birth anniversary of Syed Ahmad Ullah Maizbhandari, Darul Irfan Research Institute (DIRI) is going to organize an international conference in jointly organized with the Department of Islamic History and Culture, University of Chittagong.
